## SECTION 4: FIRST AID MEASURES

### 4.1 Description of first aid measures

#### In case of inhalation

Remove person to fresh air and keep comfortable for breathing. Obtain immediate medical attention.

#### In case of skin contact

After contact with skin, rapidly cool molten material on skin with water and seek immediate medical attention. Do not attempt to remove molten material from skin because skin will tear easily. Cuts or abrasions should be treated promptly with thorough cleansing of the affected area.

## **4.2 Most important symptoms and effects, both acute and delayed**

### **Inhalation**

At elevated temperatures, product vapours may cause irritation to the mucous membranes of the nose, the throat, bronchi, and lungs. Vapours may cause dizziness, headaches, nausea, unconsciousness. May release poisonous hydrogen sulphide gas.

### **Contact with skin**

At elevated temperatures, the hot product may cause severe skin burns. Prolonged or repeated contact with the skin may cause dermatitis.

### **Contact with skin**

At elevated temperatures, severe irritation or burns to the mouth and throat.
