SECTION 4: First aid measures

4.1 Description of first aid measures

- Take off contaminated clothing.
- Wash contaminated clothing before reuse.
- Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Get medical attention if adverse health effects persist or are severe. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

- Contact with skin

Flush contaminated skin with plenty of water. Remove contaminated clothing and shoes. Wash contaminated clothing thoroughly with water before removing it, or wear gloves. Continue to rinse for at least 10 minutes. Get medical attention. In the event of any complaints or symptoms, avoid further exposure. Wash clothing before reuse. Clean shoes thoroughly before reuse.

- Contact with eyes

Immediately flush eyes with plenty of water, occasionally lifting the upper and lower Eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention.

- Ingestion

Wash out mouth with water. Remove dentures if any. Remove victim to fresh air and keep at rest in a position comfortable for breathing. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Stop if the exposed person feels sick as vomiting may be dangerous. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Get medical attention if adverse health effects persist or are severe. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

- 4.2 Most important symptoms and effects, both acute and delayed
 - May cause allergic reaction in susceptible people

 - Immediately call a POISON CENTER or doctor/physician.

6.3 Methods and material for containment and cleaning up

- Absorb with material such as sand or polypropylene or polyethylene fiber products. Collect in suitable and properly labeled containers. Remove residual using hot soapy water. Residual resin can be removed with solvent. Solvents are not recommended for cleanup unless the recommended exposure guidelines and safe handling practices for the specific solvent are followed. Consult appropriate solvent MSDS for handling information.
