Description

Hyperplast PC323 is a high performance superplasticising admixture based on polycarboxylic ether polymers with long chains specially designed to enable the water content of the concrete to perform more effectively.

This effect can be used in high strength concrete and flowable concrete mixes, to achieve highest concrete durability and performance.

Applications

- ▲ High strength and high performance concrete.
- ★ Structures with congested reinforcement.
- Improved cohesion allow for use in mass concrete pours and piling.

Compatibility

Hyperplast PC323 can be used with all types of Portland cement and cement replacement materials. Hyperplast PC323 should not be used in conjunction with other admixtures unless DCP technical department approval is obtained.

Method of Use

Hyperplast PC323 should be added to the concrete with the mixing water to achieve optimum performance.

Automatic dispenser should be used to dispense the correct quantity of Hyperplast PC323 to the concrete mix.

Dosage

The guidance dosage of Hyperplast PC323 is 0.5 - 3.0% of cementitious materials in the mix, including GGBFS, PFA or microsilica.

Representative trials should be conducted to determine the optimum dosage of Hyperplast PC323 to meet the performance requirements by using the materials and conditions in actual use.

Effects of over dosage

Over dosing of Hyperplast PC323 will cause the following:

- ▲ Significant increase in retardation.
- ▲ Increase in workability.

Ultimate concrete strength will not be adversely affected and will generally be increased provided that proper concrete curing is maintained.

Cleaning

Hyperplast PC323 can be washed with fresh cold water.

Packaging

Hyperplast PC323 is available in 25 litre pails, 210 litre drums and 1000 litre bulks supply.

Storage
