#### 3: HAZARDS IDENTIFICATION

Hazard Information:	Flammable. Toxic by inhalation, in contact with skin and if swallowed. Causes burns. Harmful to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

#### 4: FIRST AID MEASURES
